Status of submission and review of seventh national communications and third biennial reports

Note by the secretariat

1. This note provides information on the status of submission and review of seventh national communications (NCs) and third biennial reports (BRs) from Parties included in Annex I to the Convention (Annex I Parties) as at 20 August 2019.
2. The Conference of the Parties (COP) requested Annex I Parties to submit their NC7s no later than four years after 1 January 2014¹ and their BR2s and subsequent BRs two years after the due date of a full NC.² The due date for BR3s and NC7s was 1 January 2018 and for BR4s it is 1 January 2020.
3. In addition, COP 17 adopted the “UNFCCC biennial reporting guidelines for developed country Parties” and decided that developed country Parties shall use them for the preparation of their BRs.³ COP 18 adopted the common tabular format (CTF) for those guidelines⁴ and COP 21 revised it and decided that developed country Parties shall use the revised format when preparing and submitting their BRs in accordance with decision 2/CP.17.⁵
4. At the time of the preparation of this note, the secretariat had received NC7s from 41 Annex I Parties. The NC7s of Belarus, Ukraine and the United States of America had not yet been submitted. A total of 29 Annex I Parties submitted their NC7s before the due date of submission in accordance with decision 9/CP.16, while 12 Annex I Parties submitted their NC7s after that date (6 submitted them within six weeks after that date). All NCs received have been posted on the UNFCCC website.⁶ The dates of submission and of scheduled review weeks are presented in the table below.
5. In addition, at the time of the preparation of this note, the secretariat had received 41 sets of BR3s and corresponding BR3 CTF tables from Annex I Parties. The BR3s and BR3

CTF tables of Belarus, Ukraine and the United States had not yet been submitted. A total of 31 Annex I Parties submitted their BR3s and 29 Annex I Parties submitted their BR3 CTF tables before the due date of submission in accordance with decision 2/CP.17, while 10 Annex I Parties submitted their BR3s and 12 Annex I Parties submitted their BR3 CTF tables after that date. Following the review of the BR3s, 11 Parties resubmitted their BR3 CTF tables and 5 Parties resubmitted their BR3 or NC7. All BR3s and BR3 CTF tables received have been posted on the UNFCCC website.⁷ The dates of submission and of scheduled review weeks are presented in the table below.

6. COP 20 decided that the “Guidelines for the technical review of information reported under the Convention related to greenhouse gas inventories, biennial reports and national communications by Parties included in Annex I to the Convention” shall be used for the review of BRs, effectively starting with BR2s in 2016.⁸ Those guidelines state that, in the years in which NCs and BRs are submitted together, both will be subject to an in-country review and that Annex I Parties with total emissions of less than 50 million tonnes of carbon dioxide equivalent (excluding land use, land-use change and forestry) according to their most recent greenhouse gas inventory submission, with the exception of Parties included in Annex II to the Convention, may choose for their NCs to undergo a centralized review.⁹

7. As at 20 August 2019, the secretariat had coordinated and completed the reviews of all 41 NC7s and BR3s received. In accordance with the provision referred to in paragraph 6 above, centralized reviews of NC7s and BR3s were organized by the secretariat for 10 Parties: Croatia, Cyprus, Estonia, Latvia, Liechtenstein, Lithuania, Malta, Monaco, Slovakia and Slovenia. In-depth review reports for the NC7s and technical review reports for the BR3s of all the reviewed Parties have been published (see the table below).
