- 1. This document provides information on the status of submission and review of BR4s from Annex I Parties as at 17 September 2021.
- 2. COP 17 requested Annex I Parties to submit their second and subsequent BRs two years after the due date of a full NC. The due date for BR4s was 1 January 2020.
- 3. In addition, COP 17 adopted the "UNFCCC biennial reporting guidelines for developed country Parties" and decided that developed country Parties shall use them for preparing their BRs.<sup>2</sup> COP 18 adopted the CTF for those guidelines<sup>3</sup> and COP 21 revised it and decided that developed country Parties shall use the revised format when preparing and submitting their BRs in accordance with decision 2/CP.17.<sup>4</sup>
- 4. At the time of preparation of this document, the secretariat had received 42 BR4s, including their corresponding BR4 CTF tables, from Annex I Parties; the BR4s, BR4 CTF tables and NC7s of Ukraine and the United States of America had not yet been submitted.
- 5. A total of 29 Annex I Parties submitted their BR4s and 26 Annex I Parties submitted their BR4 CTF tables before the due date of submission as per decision 2/CP.17. A total of 13 Annex I Parties submitted their BR4s and 16 Annex I Parties submitted their BR4 CTF tables after that date, 5 of which informed the secretariat about the delay in advance. All BR4s and BR4 CTF tables received have been posted on the UNFCCC website. The dates of submission and resubmission and of scheduled review weeks are presented in the table below.
- 6. COP 20 decided that the "Guidelines for the technical review of information reported under the Convention related to greenhouse gas inventories, biennial reports and national communications by Parties included in Annex I to the Convention" shall be used for the review of BRs, starting with BR2s in 2016.<sup>6</sup>
- 7. The secretariat coordinated the reviews of 41 of the submitted BR4s in nine centralized reviews.<sup>7</sup> The planned in-country review of the NC7 and BR4 of Belarus had to be postponed owing to the pandemic and is likely to take place in conjunction with the review of BR5s and NC8s.
- 8. At the time of preparation of this document, the TRRs for all BR4s reviewed had been finalized and published on the UNFCCC website. 

  8 Of those, 39 TRRs were finalized within the mandated timeline 

  9 (four months after the review week) despite the additional effort required to complete the reviews of the resubmissions while working remotely. The average time required to finalize a TRR was three months.
- 9. To further improve the reporting, 66 per cent (27 of 41) of Annex I Parties resubmitted documentation before, during or after the review week: 12 resubmitted both their BR4s and BR4 CTF tables, 15 resubmitted their BR4s and 25 resubmitted their CTF tables.
