

## **National adaptation plans**

## **Draft conclusions proposed by the Chair**

- 1. The Subsidiary Body for Implementation (SBI) welcomed:
- (a) The submissions from Parties and relevant organizations<sup>1</sup> and the synthesis report by the secretariat<sup>2</sup> on progress towards the achievement of the objectives of the process to formulate and implement national adaptation plans (NAPs), as well as experience, best practices, lessons learned, gaps and needs, and support provided and received;
- (b) The report by the Least Developed Countries Expert Group in collaboration with the Adaptation Committee, prepared with the support of the secretariat, on progress in the process to formulate and implement NAPs.<sup>3</sup>
- 2. The SBI expressed appreciation to the Government of Bangladesh for hosting the NAP Expo in Dhaka from 22 to 25 April 2024 and the meeting of Party experts<sup>4</sup> referred to in paragraph 3(d) of decision 3/CP.26 that was held in conjunction therewith.
- 3. The SBI welcomed the outcomes of the discussions held at the meeting of Party experts referred to in paragraph 2 above<sup>5</sup> and emphasized the importance of continuing the assessment of progress in the process to formulate and implement NAPs.
- 4. The SBI took note of the informal note prepared by the co-facilitators for this agenda item at this session. It decided to continue further consideration of this agenda item at SBI 61 (November 2024), taking into consideration, in particular, this informal note, with the aim of recommending a draft decision for consideration and adoption by the Conference of the Parties at its twenty-ninth session (November 2024).
