Draft decision -/CMA.7

Guidance relating to adaptation communications

The Conference of the Parties serving as the meeting of the Parties to the Paris Agreement,

Recalling Article 7, paragraphs 10–13, of the Paris Agreement and decisions <u>9/CMA.1</u> and <u>2/CMA.5</u>,

- 1. Welcomes the information submitted¹ by Parties on their experience with the application of the guidance relating to adaptation communications contained in decision 9/CMA.1 and the synthesis report thereon prepared by the secretariat;²
- 2. Recognizes the benefits of ensuring coherence in the information provided by Parties in their national adaptation plans, adaptation communications, nationally determined contributions, biennial transparency reports and national communications, keeping in mind the voluntary nature and flexibility of adaptation communications;
- 3. Also recognizes the value of the supplementary guidance for voluntary use by Parties in communicating information in accordance with the possible elements of an adaptation communication,³ prepared by the Adaptation Committee, and *requests* the secretariat to make the guidance available in all official United Nations languages;
- 4. *Notes* that a limited number of Parties and groups of Parties submitted information in response to the invitation to provide information on their experience with the application of the guidance contained in decision <u>9/CMA.1</u>,⁴ meaning that the content of the submissions does not provide a basis for undertaking a comprehensive assessment of Parties' experience;
- 5. *Invites* the Subsidiary Body for Implementation at its sixty-fourth session (June 2026) to continue consideration of the timing of initiating the following actions:
- (a) Inviting Parties to submit via the submission portal⁵ by xx further information on their experience with the application of the guidance contained in decision <u>9/CMA.1</u>;
- (b) Requesting the secretariat to prepare a synthesis report on the submissions referred to in paragraphs 1 and 5(a) above for consideration by the Subsidiary Body for Implementation at its xx session (month and year of session);
- (c) Taking stock of, and if necessary revising, the guidance contained in decision <u>9/CMA.1</u>, taking into account the submissions referred to in paragraphs 1 and 5(a) above and the synthesis report referred to in paragraph 5(b) above, at its xx session (month and year of session);
- 6. *Takes note* of the estimated budgetary implications of the activities to be undertaken by the secretariat referred to in paragraph 3 above;
- 7. *Requests* that the actions of the secretariat called for in this decision be undertaken subject to the availability of financial resources.

Draft decision [-/CMA.7] [-/CP.30]

Joint annual report of the Executive Committee of the Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts and the Santiago network for averting, minimizing and addressing loss and damage associated with the adverse effects of climate change for 2024

The [Conference of the Parties serving as the meeting of the Parties to the Paris Agreement][Conference of the Parties],¹

Recalling the Paris Agreement and relevant decisions of the Conference of the Parties and the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement,

- 1. *Reiterates* its welcoming² of the progress of the Executive Committee of the Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts in implementing its rolling workplan for 2023–2027;³
- 2. Also reiterates its welcoming⁴ of the progress of the Advisory Board and the interim secretariat of the Santiago network for averting, minimizing and addressing loss and damage associated with the adverse effects of climate change in operationalizing the Santiago network;
- 3. *Takes note* of the joint annual report of the Executive Committee of the Warsaw International Mechanism and the Santiago network for 2024,⁵ which also contains:
- (a) The report of the Executive Committee of the Warsaw International Mechanism,⁶ which includes recommendations from the Executive Committee;
- (b) The report of the Santiago network, which includes recommendations from the Advisory Board of the Santiago network.

Nothing in this draft decision prejudices Parties' views or prejudges outcomes on matters related to the governance of the Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts.

Draft decision -/CP.30

Administrative, financial and institutional matters

The Conference of the Parties,

Recalling the UNFCCC financial procedures, in particular paragraph 5,

Also recalling Article 8, paragraph 2(f), of the Convention and Article 17, paragraph 2, of the Paris Agreement,

Having considered the information contained in the documents prepared by the secretariat on administrative, financial and institutional matters, including the proposed programme budget for the biennium 2026–2027,²

Noting that the substantive information contained in the documents prepared by the secretariat does not necessarily represent the views or interpretations of Parties,

Also noting the improvement of the methodology applied by the secretariat in developing the programme budget for the biennium 2026–2027 compared with previous programme budgets, including the early engagement with Parties and implementation of recommendations from the United Nations Board of Auditors,

I. Programme budget for the biennium 2026–2027

- 1. *Approves* the programme budget for the biennium 2026–2027, amounting to EUR 81,516,062, for the purposes specified in table 1;
- 2. Requests the secretariat, in implementing its work programme for the biennium 2026–2027 on the basis of the budget approved in paragraph 1 above, to continue to allocate adequate resources to UNFCCC constituted bodies in support of their response to the mandates from the governing bodies and for the full delivery of their work programmes, to transparency (including the enhanced transparency framework under the Paris Agreement) and to adaptation-related activities, while continuing to apply the established budget methodology, including for any new mandate;
- 3. *Notes with appreciation* the annual contribution of EUR 766,938 from the Host Government to the core budget;
- 4. Approves 201 secretariat staffing positions to be funded from the core budget for 2026–2027 for the purposes specified in table 1 and in line with the balance among appropriation lines reflected in table 1;
- 5. *Notes* that the programme budget contains elements relating to the Convention and the Paris Agreement as well as the Kyoto Protocol;
- 6. *Adopts* the indicative scale of contributions contained in the annex;
- 7. *Notes* that the indicative scale of contributions covers 98 per cent of the contributions specified in table 1;
- 8. *Invites* the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol, at its twentieth session (November 2025), to endorse the elements of the approved budget as it applies to the Kyoto Protocol;
- 9. *Also invites* the United Nations General Assembly to continue to provide resources for conference services from its regular budget;
- 10. Approves a contingency budget for conference services, amounting to EUR 11,679,400, to be added to the programme budget in the event that the United Nations

General Assembly does not provide resources for these activities in the United Nations regular budget (see table 2);

- 11. *Requests* the Executive Secretary to report to the Subsidiary Body for Implementation on the implementation of the matters referred to in paragraphs 9–10 above, as necessary;
- 12. Authorizes the Executive Secretary to make transfers between each of the appropriation lines set out in table 1, up to an aggregate limit of 15 per cent of total estimated expenditure for those appropriation lines, provided that a further limitation of up to -25 per cent of each such appropriation line shall apply, while ensuring no negative impacts on the activities under each division;
- 13. *Decides* to maintain the level of the working capital reserve at 8.3 per cent of the estimated expenditure;
- 14. *Takes note* of the funding estimates of EUR 16.2 million for the trust fund for participation in the UNFCCC process and EUR 142.9 million for the trust fund for supplementary activities for the biennium 2026–2027 (see tables 3–4);
- 15. *Invites* Parties to make contributions to the trust funds referred to in paragraph 14 above and *encourages* the secretariat to continue its fundraising efforts;
- 16. Affirms the urgency and importance of this matter and reaffirms its decision that Parties will seek to approve future core budgets that include all category 1 (essential) and 2 (long-term, recurring) activities that have been mandated by the Conference of the Parties and the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement;
- 17. Acknowledges the cost implications of implementing the increasing number of mandates;
- 18. *Recalls* its request to the secretariat to prepare an information document after each session of the Conference of the Parties that presents activities mandated at that session and their respective cost implications for the information of Parties³ and *requests* the secretariat to produce budget documents that provide more clarity and transparency on total costs as well as the costs of activities associated with workstreams;
- 19. *Notes with appreciation* the efforts of the secretariat to implement efficiency measures and engage Parties early in the development of the programme budget for the biennium 2026–2027 and *requests* the secretariat to further enhance its efforts to identify and implement efficiency gains;
- 20. Also requests the Executive Secretary to propose to the Conference of the Parties at its thirty-first session (November 2026) any necessary adjustments to the programme budget for the biennium 2026–2027, supported by a report on income and budget performance for 1 January to 30 June 2026;

- 21. *Takes note* of the relevant information contained in the documents on the budget performance for the biennium 2024–2025,⁴ the updated work programme of the secretariat for the biennium 2024–2025⁵ and the status of contributions and fees as at 30 May 2025;⁶
- 22. Also takes note that the substantive information contained in the documents prepared by the secretariat does not necessarily represent the views or interpretations of Parties;
- 23. Expresses appreciation to Parties that made contributions to the core budget in a timely manner;
- 24. *Expresses concern* regarding the high level of outstanding contributions to the core budget,⁷ which has resulted in difficulties with both cash flow and the effective implementation of activities;

- 25. *Strongly urges* Parties that have not made contributions in full to the core budget for the current and/or previous bienniums to do so without further delay;
- 26. Expresses appreciation for the contributions to the trust fund for participation in the UNFCCC process and to the trust fund for supplementary activities received from Parties, including those contributions that allow for greater flexibility in allocation;
- 27. Reiterates appreciation to the Government of Germany for its special contribution of EUR 1,789,522 as Host Government of the secretariat as well as its additional one-time contribution of EUR 1,640,000;
- 28. *Requests* the Executive Secretary to take further measures to reduce Parties' outstanding contributions;

III. Other financial and budgetary matters

- 29. *Takes note* of the information contained in the documents prepared by the secretariat on other financial and budgetary matters;⁸
- 30. *Notes* that the substantive information contained in the documents prepared by the secretariat does not necessarily represent the views or interpretations of Parties;
- 31. *Decides* that the scale of contributions contained in the annex shall also be applicable for 2025, covering 92 per cent of the contributions specified in table 1 of decision 19/CP.28;9
- 32. *Requests* the secretariat to continue implementing the recommendations of the United Nations Board of Auditors in a timely manner;
- 33. Also requests the secretariat to take the necessary measures to strive for equitable geographical representation across all levels of staffing in accordance with the Staff Regulations and Rules of the United Nations, ¹⁰ recognizing that regional balance contributes meaningfully to the inclusivity, effectiveness and legitimacy of its work;
- 34. Further requests the secretariat to deploy a version of the UNFCCC website in Arabic, in line with the principle of equal treatment of the six official languages of the United Nations;
- 35. *Welcomes* the timely publication of the programme budget for the biennium 2026–2027:¹¹
- 36. *Notes with concern* that some of the documents on administrative, financial and institutional matters prepared for the sixty-second session of the Subsidiary Body for Implementation were not made available in a timely manner and *reiterates* its request¹² for the secretariat to issue documents in a timely manner, at least four weeks before the opening of each session:
- 37. *Takes note* of the estimated budgetary implications of the activities to be undertaken by the secretariat referred to in paragraphs 33–34 above;
- 38. *Requests* that *the* actions of the secretariat called for in this decision be undertaken subject to the availability of financial resources.
