I. Opening of the session

(Agenda item 1)

1. SBI 63 was held at the Hangar Convention and Fair Centre of the Amazon in Belém, Brazil, from 10 to 15 November 2025.
2. The SBI Chair, Julia Gardiner (Australia), opened the session and welcomed all Parties and observers. She also welcomed Eyad Aljubran (Saudi Arabia) as Vice-Chair and Kamil Salazar (Belize) as Rapporteur.

II. Organizational matters

(Agenda item 2)

A. Adoption of the agenda

(Agenda sub-item 2(a))

3. At the 1st meeting of SBI 63, held together with the 1st meeting of SBSTA 63, on 10 November, the SBI considered document [FCCC/SBI/2025/12](#), containing the provisional agenda. Following consultations with Parties on the adoption of the agendas for SB 63, the SBI and SBSTA Chairs proposed that the provisional agendas be amended to add a footnote to joint SBI 63 agenda item 9 and SBSTA 63 agenda item 8, “United Arab Emirates just transition work programme” (replicating footnote 7 from the reports on SBI 62 and SBSTA 62¹), which was to read as follows: “See paragraph 6(b–c) in document [FCCC/SBI/2025/11](#) and paragraph 6(b–c) in document [FCCC/SBSTA/2025/4](#). Related issues will be discussed under relevant agenda items, including the United Arab Emirates just transition work programme.”
4. With regard to item 20 of the supplementary provisional agenda for SBI 62, titled “Implementation of Article 9, paragraph 1, of the Paris Agreement”, a footnote to sub-item 2(a) of the agenda was added, replicating footnote 2 from the report on SBI 62 (see footnote 4 in this document)²

B. Organization of the work of the session

(Agenda sub-item 2(b))

6. At the 1st meeting, the SBI Chair recalled the proposal for the organization of work outlined in the note⁶ that she prepared jointly with the SBSTA Chair taking into account views expressed by Parties during pre-session consultations.

7. The SBI Chair encouraged Parties to engage constructively in the negotiations and respect meeting times, recalling the deadline for all groups to conclude work by noon on 14 November in order to ensure the timely availability of draft conclusions in all official languages of the United Nations for the closing plenary on 15 November. She encouraged Parties to keep all informal consultations open to observers in accordance with established practice.⁷ On a proposal by the Chair, the SBI agreed to proceed on that basis and in line with previously adopted SBI conclusions.⁸

8. All documents prepared for this session are available on the UNFCCC website.⁹

9. At the 2nd meeting of SBI 63, held together with the 2nd meetings of SBSTA 63, COP 30, CMP 20 and CMA 7, on 11 November, statements were made by representatives of 33 Parties, including 15 on behalf of groups of Parties: African Group; Alliance of Small Island States; Arab Group; Bolivarian Alliance for the Peoples of Our America – Peoples' Trade Treaty; Brazil, South Africa, India and China; Coalition for Rainforest Nations; Environmental Integrity Group; European Union and its member States; Group of 77 and China; Group SUR; Independent Association for Latin America and the Caribbean; least developed countries; Like-minded Developing Countries; Mountain Group; and Umbrella Group.¹⁰

10. Statements were also made by representatives of six intergovernmental organizations: Committee on Earth Observation Satellites on behalf of itself and the Coordination Group for Meteorological Satellites; Food and Agriculture Organization of the United Nations on behalf of the Collaborative Partnership on Forests; International Civil Aviation Organization; International Maritime Organization; Intergovernmental Panel on Climate Change; and

World Meteorological Organization on behalf of itself, the Global Climate Observing System and the World Climate Research Programme.¹¹

11. Statements were also made by representatives of the nine UNFCCC constituencies of non-governmental organizations: business and industry, children and youth, environmental, farmers and agricultural, research and independent, and trade union non-governmental organizations, Indigenous Peoples organizations, local government and municipal authorities, and women and gender constituency.¹²

C. Facilitative sharing of views under the international consultation and analysis process

(Agenda sub-item 2(c))

12. At its 1st meeting, the SBI took note of the information provided by its Chair on the nineteenth workshop for the facilitative sharing of views under the international consultation and analysis process,¹³ which took place in conjunction with this session featuring three non-Annex I Parties.¹⁴

D. Facilitative, multilateral consideration of progress

(Agenda sub-item 2(d))

13. At its 1st meeting, the SBI took note of the information provided by its Chair on the second working group session for the facilitative, multilateral consideration of progress,¹⁵ which took place in conjunction with this session featuring nine Parties.^{16, 17}

E. Mandated events

(Agenda sub-item 2(e))

14. At its 1st meeting, the SBI took note of the information provided by its Chair on the mandated events being held in conjunction with this session.¹⁸

15. At its 1st meeting, the SBI considered the 2025 report prepared by the secretariat on national greenhouse gas inventory data for 1990–2023.¹⁹

16. The SBI agreed to defer consideration of this matter to SBI 64 (June 2026).
17. A statement was made by a representative of one Party.²⁰

IV. Reporting from Parties not included in Annex I to the Convention

(Agenda item 4)

A. Information contained in national communications

(Agenda sub-item 4(a) *held in abeyance*)

B. Provision of financial and technical support

(Agenda sub-item 4(b))

1. Proceedings

18. At its 1st meeting, the SBI agreed to consider this matter in informal consultations to be held back-to-back with informal consultations for agenda item 5, “Reporting and review pursuant to Article 13 of the Paris Agreement: provision of financial and technical support to developing country Parties for reporting and capacity-building”, and co-facilitated by Sandra Motshwanedi (South Africa) and Ole-Kenneth Nielsen (Denmark).

19. At its 3rd meeting, on 15 November, the SBI considered and adopted the conclusions below.

2. Conclusions

20. The SBI welcomed the information provided by the GEF in its report to COP 30²¹ on financial support requested, approved and provided for the preparation of NCs and BURs by non-Annex I Parties, including support provided through CBIT–GSP, and noted with appreciation the progress in the submission of NCs and BURs.

21. The SBI acknowledged the importance of the financial and technical support available through bilateral, multilateral and other channels, in particular that provided by the GEF, including through CBIT–GSP, to support the efforts of non-Annex I Parties in fulfilling reporting obligations under the existing measurement, reporting and verification arrangements under the Convention, including for NCs.

22. The SBI noted with appreciation the efforts of the GEF in developing streamlined processes for enabling activities and, recalling paragraphs 39 and 43(a) of decision [1/CP.24](#), in providing the modality for Parties to submit their NC and BTR as a single report, noting that doing so reduces the reporting burden on Parties.

23. The SBI encouraged non-Annex I Parties that are not Parties to the Paris Agreement and that have received funding for preparing and submitting a BUR, but have not yet done so, to do so as soon as possible.

24. The SBI welcomed the increase in the allocation to the climate change focal area set aside for enabling activities and the Capacity-building Initiative for Transparency, from USD 165 million in the seventh replenishment cycle of the GEF to USD 220 million in the eighth, and that, within the agreed resource allocation framework for the eighth replenishment, USD 75 million has been allocated to the Capacity-building Initiative for Transparency and USD 145 million to other enabling activities, representing a 36 and 32 per cent increase respectively compared with the allocation in the seventh cycle.²²

25. The SBI underscored the importance of providing adequate and timely financial and technical support to non-Annex I Parties to meet their measurement, reporting and verification requirements under the Convention, and to build and enhance their institutional and technical capacity on a continuous basis.

26. The SBI also underscored the importance of the GEF continuing to periodically review and report on its support provided for the preparation of NCs by non-Annex I Parties, including for national technical teams, tools, data systems and workflows.

27. The SBI, noting that the obligation to prepare and submit NCs will continue²³ and in the light of continued challenges in reporting faced by non-Annex I Parties, highlighted the importance of financial support and technical assistance, and capacity-building support for facilitating and maintaining continuity in meeting their reporting requirements under the Convention, as well as building and enhancing their domestic institutional and technical capacity, in a sustainable and continuous manner, including for establishing and enhancing national reporting systems within their national Governments, agencies, statutory bodies and associated institutions, as applicable.

28. The SBI requested the secretariat to provide, in collaboration with other United Nations entities and international organizations, further technical support to non-Annex I Parties for their reporting under the Convention.

29. The SBI noted that, as at 13 November 2025, 480 NCs (i.e. 154 NC1s, 147 NC2s, 118 NC3s, 48 NC4s, 11 NC5s and 2 NC6s) and 209 BURs (i.e. 115 first BURs, 46 second BURs, 28 third BURs, 15 fourth BURs and 5 fifth BURs) had been submitted by non-Annex I Parties.²⁴

30. The SBI agreed to continue consideration of this matter, including the frequency of including this matter in the agenda for future sessions of the SBI, at SBI 64.

31. The SBI took note of the estimated budgetary implications of the activities to be undertaken by the secretariat referred to in paragraph 28 above.

32. The SBI requested that the actions of the secretariat called for in these conclusions be undertaken subject to the availability of financial resources.

C. Summary reports on the technical analysis of biennial update reports

(Agenda sub-item 4(c))

33. At its 1st meeting, the SBI took note of the summary reports on the technical analysis of BURs finalized prior to 3 September 2025 and published on the UNFCCC website.²⁵

D. Term, composition, terms of reference and report of the Consultative Group of Experts

(Agenda sub-item 4(d))

1. Proceedings

34. At its 1st meeting, the SBI agreed to consider this matter in informal consultations co-facilitated by Hans Kolshus (Norway) and Tian Wang (China).

35. At its 3rd meeting, the SBI considered and adopted the conclusions below.

2. Conclusions

36. The SBI welcomed the oral report²⁶ of the CGE at this session on its progress in implementing its workplan for 2025.²⁷

37. The SBI acknowledged the achievements²⁸ of the CGE and expressed appreciation to the CGE for its progress in implementing its workplan for 2025 and for continuing to provide technical advice and support to developing country Parties.

38. The SBI recognized that the CGE plays an important role in facilitating the provision of technical advice and support to developing country Parties and in facilitating improved reporting over time, in relation to the preparation and submission of NCs, BURs and BTRs, as applicable.

39. The SBI noted with concern that, owing to limited financial resources available, the CGE was unable to hold its second meeting in 2025 and therefore was also unable to prepare its 2025 progress report for consideration at this session.

40. The SBI underlined the importance of having adequate financial resources available to support the CGE in implementing its annual workplan, including the two mandated meetings held by the CGE each year.

41. The SBI noted that the CGE continued to collaborate, to the extent possible, with expert groups and other constituted bodies under the Convention and the Paris Agreement, as well as with relevant multilateral programmes and organizations, in implementing its workplan for 2025, while avoiding duplication of work. The SBI encouraged the continuation of such collaboration, as appropriate, in implementing its workplan for 2026.

42. The SBI expressed gratitude to the Governments of Brazil, Egypt, Fiji, Grenada, Nigeria, Peru, Senegal, Seychelles and Türkiye for hosting the subregional hands-on training workshops organized by the CGE in 2025²⁹ and expressed appreciation to the partners of the CGE that collaborated with the CGE on the delivery of the workshops.³⁰

43. The SBI also expressed appreciation to the Parties that provided financial contributions to support the work of the CGE in 2025.

44. The SBI noted with concern the number of vacancies in the CGE membership and urged Parties to submit nominations as soon as possible.

45. The SBI, recognizing the challenges faced by developing country Parties, in particular countries with the least capacity, such as the least developed countries, and those that are particularly vulnerable to the adverse effects of climate change, such as small island developing States, in fulfilling the reporting requirements under the ETF, requested the CGE, in developing and implementing its workplan for 2026, to consider including the following activities, to the extent possible:

(a) Continuing to prepare updates of the technical paper on problems, constraints, lessons learned and capacity-building needs in preparing NCs, BURs and BTRs;³¹

(b) Providing advice and support to Parties, including Parties that are still in the process of producing their BTR1, including the provision of detailed guidance on understanding the modalities, procedures and guidelines for the transparency framework for action and support referred to in Article 13 of the Paris Agreement, and the common tabular formats and common reporting tables for the ETF, including the flexibility provisions;

(c) Continuing to focus its work on facilitating the preparation and submission of BTRs by developing country Parties, including through development of capacity-building materials and use of the ETF electronic reporting tools, taking into account the findings in the technical paper referred to in paragraph 45(a) above;

(d) Providing technical advice and support to developing country Parties for undergoing the technical expert review of BTRs and the facilitative, multilateral consideration of progress;

(e) Continuing to pursue collaboration with other entities, as appropriate, in providing capacity-building for developing country Parties, in fulfilment of the terms of reference of the CGE;

(f) Updating the *CGE Training Material on Reporting Information Related to Climate Change Impacts and Adaptation*³² taking into account paragraphs 9, 10 and 44 of decision [2/CMA.5](#);

(g) Continuing to provide technical advice and support to developing country Parties for the preparation and submission of NCs and BURs under the Convention, particularly to countries facing ongoing capacity constraints in meeting their reporting obligations under the Convention.

46. The SBI engaged constructively and agreed to forward this matter to COP 30 for further consideration taking into account the draft text available on the UNFCCC website.³³

V. Reporting and review pursuant to Article 13 of the Paris Agreement: provision of financial and technical support to developing country Parties for reporting and capacity-building

(Agenda item 5)

1. Proceedings

47. At its 1st meeting, the SBI agreed to consider this matter in informal consultations to be held back-to-back with informal consultations for agenda sub-item 4(b), “Provision of financial and technical support”, and co-facilitated by Sandra Motshwanedi and Ole-Kenneth Nielsen.

48. At its 3rd meeting, the SBI considered and adopted the conclusions below.

2. Conclusions

49. The SBI engaged constructively and agreed to forward this matter to CMA 7 for further consideration³⁴ taking into account the informal note containing elements of a draft decision available on the UNFCCC website.³⁵

VI. Matters relating to the global stocktake

(Agenda item 6)

A. Procedural and logistical elements of the overall global stocktake process*

(Agenda sub-item 6(a))

1. Proceedings

50. At its 1st meeting, the SBI agreed that this sub-item would be considered together with the equally titled SBSTA 63 agenda item 3 in informal consultations co-facilitated by Eduardo Silva Besa (Chile) and Kelsey Gray (Australia).

They recognized that the draft text includes divergent views, has not been agreed upon, does not reflect consensus, is not exhaustive, has no formal status, is open to revision and does not prejudice further work or prevent Parties from expressing any further views.

B. Modalities of the United Arab Emirates dialogue on implementing the global stocktake outcomes, referred to in paragraph 97 of decision 1/CMA.5

(Agenda sub-item 6(b))

1. Proceedings

53. At its 1st meeting, the SBI agreed to consider this matter in informal consultations co-facilitated by Ricardo Marshall (Barbados) and Patrick Spicer (Canada).

54. At its 3rd meeting, the SBI considered and adopted the conclusions below.

2. Conclusions

55. The SBI agreed to forward this matter to CMA 7 for consideration³⁸ under its agenda sub-item 10(h) on the basis of the informal note³⁹ prepared by the co-facilitators for this agenda sub-item at this session. The SBI recognized that the informal note includes divergent views, has not been agreed upon, does not reflect consensus, is not exhaustive, has no formal status, is open to revision and does not prejudice further work or prevent Parties from expressing any further views.

VII. Report of the administrator of the international transaction log under the Kyoto Protocol

(Agenda item 7)

56. At its 1st meeting, the SBI agreed to consider this matter in informal consultations co-facilitated by Alick Muvundika (Zambia) and Peer Stiansen (Norway). As Alick Muvundika could not attend this session, the informal consultations were facilitated by Peer Stiansen.

57. At its 3rd meeting, the SBI took note of the 2025 report of the administrator of the international transaction log under the Kyoto Protocol⁴⁰ and recommended a draft decision for consideration and adoption at CMP 20.⁴¹

59. At its 3rd meeting, the SBI considered and adopted the conclusions below.

2. Conclusions

60. The SBI and the SBSTA agreed to forward this matter to CMA 7 for consideration⁴² under its agenda item 6, taking into account the informal note⁴³ prepared by the co-facilitators for the relevant agenda items at SB 63.

61. The SBI and the SBSTA recognized that the informal text was prepared by the co-facilitators under their own responsibility, has no formal status, does not prejudice further work or prevent Parties from expressing any further views at any time, does not represent agreement among Parties and is without prejudice to what will form the basis for negotiation.

IX. United Arab Emirates just transition work programme*

(Agenda item 9)

1. Proceedings

62. At its 1st meeting, the SBI agreed that this item would be considered together with the equally titled SBSTA 63 agenda item 8 in a contact group co-chaired by Federica Fricano (Italy) and Joseph Teo (Singapore).

63. At its 3rd meeting, the SBI considered and adopted the conclusions below.

2. Conclusions

64. The SBI and the SBSTA considered matters relating to the implementation of the United Arab Emirates just transition work programme.

65. The SBI and the SBSTA agreed to forward this matter for further consideration at CMA 7,⁴⁴ taking note of the informal note⁴⁵ prepared by the co-chairs for the relevant agenda items at SB 63 under their own responsibility, recognizing that it includes divergent views, has not been agreed upon, is not exhaustive, has no formal status, is open to revision, and does not prejudice further work, prevent Parties from expressing any further views or reflect consensus or all the views shared and proposals made by Parties.

66. The SBI and the SBSTA invited the CMA to take note of the exchanges of views and written inputs by Parties under these agenda items at these sessions, including Party views on the summary reports on the dialogues held under the work programme in 2024–2025,⁴⁶ and also invited the CMA to take into account the views and submissions of Parties in the next iteration of the informal note.

67. At its 1st meeting, the SBI agreed that this item would be considered together with the equally titled SBSTA 63 agenda item 9 in a contact group co-chaired by Veronica Bagi (Hungary) and Zita Kassa Wilks (Gabon).

68. At its 3rd meeting, the SBI considered and adopted the conclusions below.

2. Conclusions

69. The SBI and the SBSTA could not conclude consideration of this matter at SB 63.

70. They agreed to forward the matter to COP 30, CMP 20 and CMA 7 for further guidance⁴⁷ taking into account the draft text available on the UNFCCC website for the relevant agenda items.⁴⁸

XI. Sharm el-Sheikh joint work on implementation of climate action on agriculture and food security*

(Agenda item 11)

1. Proceedings

71. At its 1st meeting, the SBI agreed that this item would be considered together with the equally titled SBSTA 63 agenda item 10 in informal consultations co-facilitated by UnaMay Gordon (Belize) and Claudia Heidecke (Germany).

72. At its 3rd meeting, the SBI considered and adopted the conclusions below.

2. Conclusions

73. The SBI and the SBSTA continued consideration of the Sharm el-Sheikh joint work on implementation of climate action on agriculture and food security.⁴⁹

74. The SBI and the SBSTA recognized that progress was made at SB 63 in considering the report on the first in-session workshop as part of the Sharm el-Sheikh joint work,⁵⁰ on the topic of systemic and holistic approaches to implementing climate action on agriculture, food systems⁵¹ and food security, understanding, cooperation and integration into plans,⁵² and noted that more time is needed to conclude the discussions thereon.

75. The SBI and the SBSTA reiterated the importance of cooperating on the implementation of climate action to address issues related to agriculture and food security in accordance with the Sharm el-Sheikh joint work.

76. The SBI and the SBSTA agreed to continue consideration of this matter at SB 64 (June 2026) taking into account the draft text⁵³ prepared for the relevant agenda items at SB 63.

(a) In paragraph 8, the semicolons were replaced with commas, and the word “nor” was added in the third and fourth lines;

(b) In paragraph 10, the second “new” was deleted.

81. This text was forwarded as a proposal by the Chairs of the subsidiary bodies, which includes divergent views, has not been agreed upon, does not reflect consensus, is not exhaustive, has no formal status, is open to revision and does not prejudice further work or prevent Parties from expressing any further views.

B. Report of the Adaptation Committee*

(Agenda sub-item 12(b))

82. At the 1st meeting, the SBI and the SBSTA recommended that COP 30 and CMA 7 welcome the 2025 report of the Adaptation Committee.⁵⁷

C. Review of the progress, effectiveness and performance of the Adaptation Committee*

(Agenda sub-item 12(c))

83. At the 1st meeting, the SBI and the SBSTA agreed to defer consideration of this matter to SB 64.

87. At its 1st meeting, the SBI agreed to consider this matter in informal consultations co-facilitated by Rik den Hoedt (Kingdom of the Netherlands) and Ephraim Shitima (Zambia).

88. At its 3rd meeting, the SBI considered and adopted the conclusions below.

2. Conclusions

89. The SBI welcomed the report on the 48th meeting of the Least Developed Countries Expert Group,⁶⁰ held in Lusaka from 18 to 20 August 2025.

90. The SBI considered the steps for the stocktake of the work of the Least Developed Countries Expert Group mandated to take place at COP 31 (November 2026) and CMA 8 (November 2026), the midway point before the review of the mandate of the Group at COP 36 (November 2031).⁶¹

91. The SBI recommended draft decisions on this matter for consideration and adoption at COP 30 and CMA 7.⁶²

94. At its 1st meeting, the SBI agreed that this sub-item would be considered together with the equally titled SBSTA 63 agenda sub-item 6(b) in informal consultations co-facilitated by Cornelia Jaeger and Pepetua Latasi.

95. At its 3rd meeting, the SBI considered and adopted the conclusions below.

2. Conclusions

96. The SBI and the SBSTA agreed to forward this matter to the governing body or bodies for consideration⁶⁵ at the session(s) in November 2025 taking into account the informal note prepared by the co-facilitators for the relevant agenda sub-items at SB 63 available on the UNFCCC website.⁶⁶ They confirmed that the informal note has no status, does not prejudice further work or prevent Parties from expressing views at any time, does not represent agreement among Parties and is without prejudice to what will form the basis for negotiation.

110. At its 3rd meeting, the SBI considered and adopted the conclusions below.

111. Statements were made by representatives of five Parties, including two on behalf of groups of Parties.⁷⁵

2. Conclusions

112. The SBI could not conclude consideration of matters relating to the Adaptation Fund at this session and agreed to forward this matter to CMP 20 and CMA 7 for further consideration.

B. Second review of the functions of the Standing Committee on Finance

113. At its 1st meeting, the SBI agreed to defer consideration of this matter to SBI 64.

121. The SBI agreed to forward this matter to COP 30 for further consideration⁷⁹ on the basis of the draft text⁸⁰ prepared by the co-facilitators for this agenda item at this session, noting that the draft text being forwarded does not represent consensus among Parties.

XIX. Matters relating to Action for Climate Empowerment

(Agenda item 19)

1. Proceedings

122. At its 1st meeting, the SBI agreed to consider this matter in informal consultations co-facilitated by Arne Riedel (Germany) and Carol Simon (Panama).

123. At its 3rd meeting, the SBI considered and adopted the conclusions below.

2. Conclusions

124. The SBI recommended draft decisions for consideration and adoption at COP 30 and CMA 7.⁸¹

XX. Arrangements for intergovernmental meetings

(Agenda item 20)

1. Proceedings

125. At its 1st meeting, the SBI agreed to consider this matter in informal consultations co-facilitated by Kaveh Guilanpour (Georgia) and Marianne Karlsen (Norway).

126. At its 3rd meeting, the SBI considered and adopted the conclusions below.

127. Statements were made by representatives of two Parties, including one on behalf of a group of Parties.⁸²

2. Conclusions

128. The SBI urged the Western European and other States to finalize their consultations and submit an offer to host COP 31, to be held from Monday, 9 November, to Friday, 20 November 2026, for consideration and adoption at COP 30, noting the logistical and financial risks associated with delays in selecting a host country and the need for the secretariat to conduct fact-finding missions to the host country in a timely manner.

129. The SBI expressed appreciation to the Government of Ethiopia for its offer to host COP 32, to be held from Monday, 8 November, to Friday, 19 November 2027.

130. The SBI recommended that COP 30 adopt a decision to accept the offer by the Government of Ethiopia to host COP 32.

(a) Increasing the efficiency of the UNFCCC process

131. The SBI welcomed the rich exchange of views among Parties at this session on increasing the efficiency of the UNFCCC process towards enhancing ambition and strengthening implementation.

132. The SBI also welcomed the efforts of the presiding officers and the secretariat to ensure efficiency, coordination, coherence and due process in the consideration of issues under discussion, including mandated events. The SBI reiterated its encouragement to them, as well as to future presiding officers of the governing and subsidiary bodies, to continue efforts in this regard,⁸³ while respecting the Party-driven nature of the UNFCCC process and the draft rules of procedure being applied.⁸⁴

133. The SBI invited Parties to pursue efficiency in the consideration of matters under agenda items at sessions of the governing and subsidiary bodies, while respecting the Party-driven nature of the UNFCCC process and the draft rules of procedure being applied.

134. The SBI took note of the views of Parties and the efforts of the secretariat to cluster mandated events so that several are held in a single location within a relatively short time frame, such as during climate weeks or sessions of the governing and subsidiary bodies. The SBI requested the secretariat to continue to cluster mandated events where feasible with a view to maximizing participation therein, in particular by ensuring the effective participation of developing country Parties and increasing the efficiency of the UNFCCC process. The SBI also requested that mandated events be appropriately budgeted for to enable effective organization thereof and participation therein.

135. The SBI reaffirmed the conclusions⁸⁵ on this matter adopted at SBI 62, emphasized their relevance to further efforts to increase the efficiency of the UNFCCC process and agreed to continue consideration of the matter at SBI 64.

136. The SBI took note of the estimated budgetary implications of the activities to be undertaken by the secretariat referred to in paragraph 134 above.

137. The SBI requested that the actions of the secretariat called for in these conclusions be undertaken subject to the availability of financial resources.

XXI. Administrative, financial and institutional matters

(Agenda item 21)

1. Proceedings

138. At the 1st meeting, the Chair recalled that, in addition to the consideration of the financial statements, audit reports, updates of the work programme, notes on funding the core and supplementary budgets and the status of contributions and fees,⁸⁶ the SBI was invited to consider the note by the secretariat on important changes to the secretariat's administrative issuances.⁸⁷ The SBI agreed to consider this matter in a contact group co-chaired by Lenneke Ijzendorp (Kingdom of the Netherlands) and Pacifica F. Achieng Ogola (Kenya).

139. At the same meeting, the SBI also agreed that a spin-off group would be established and facilitated by Abzeita Djigma (Burkina Faso) to consider the proposed budget for the international transaction log for the biennium 2026–2027.

140. At its 3rd meeting, the SBI recommended draft decisions for consideration and adoption at COP 30 and CMP 20.⁸⁸

141. At the same meeting, the SBI considered and adopted the conclusions below.

2. Conclusions

142. The SBI took note of the information contained in the documents on administrative, financial and institutional matters prepared by the secretariat.⁸⁹

143. The SBI agreed to forward the matter of the budget for the international transaction log to CMP 20 for consideration⁹⁰ taking into account the draft text prepared by the co-chairs for this agenda item at this session available on the UNFCCC website.⁹¹

XXII. Other matters

(Agenda item 22)

144. The SBI considered this agenda item at its 1st meeting.

145. At the same meeting, the SBI and SBSTA Chairs reported on the outcomes of their substantive consultations conducted at SB 62 to consider substantive elements regarding the implementation of Article 9, paragraph 1, of the Paris Agreement, as agreed at the opening of SB 62.^{92, 93}

146. Following a request by some Parties,⁹⁴ the Chairs also convened an informal meeting on 14 November to report back in more depth and to enable more Parties to be present and react to the report.

147. At the 3rd meeting, the Chairs reported on the informal meeting. They took note of the concerns raised by Parties and noted that they would convey them to the COP 30 Presidency

as part of the ongoing consultations on this matter. The Chairs noted that this reporting back to Parties concluded the consideration of this matter under the subsidiary bodies.

XXIII. Closure of and report on the session

(Agenda item 23)

1. Administrative and budgetary implications

148. At the 3rd meeting, the UNFCCC Deputy Executive Secretary informed the SBI that additional activities mandated at this session require additional resources over and above the core budget for the biennium 2026–2027.⁹⁵ Relevant requests for activities are contained in conclusions adopted under various SBI, including joint SBI–SBSTA, agenda items.

149. The Deputy Executive Secretary noted that all requested activities are categorized as temporary or short term activities unless otherwise specified,⁹⁶ and that the amounts presented are preliminary and based on information available at the time.⁹⁷ She noted that the secretariat is counting on Parties to provide supplementary funding for these activities in a timely and predictable manner, as without such contributions the secretariat will not be in a position to provide the requested support.

150. The Deputy Executive Secretary concluded by noting that costs for 2028 and beyond will be reviewed in the context of preparing the budget for the biennium 2028–2029.

151. Statements were made by representatives of two Parties, including one on behalf of a group of Parties.⁹⁸

2. Closure of and report on the session

152. At the 3rd meeting, the SBI considered and adopted the draft report on the session and authorized the Rapporteur, with the assistance of the secretariat and under the guidance of the Chair, to complete the report on the session and make it available to Parties.

153. The Chair thanked all Parties and observers for their constructive engagement throughout the session. She also thanked the co-chairs of contact groups and co-facilitators of informal consultations for their work. The Chair then closed the session.
