Revised indicative contributions for 2025

Note by the secretariat

1. The UNFCCC financial procedures state that contributions will be made each year by Parties on the basis of an indicative scale, adopted by consensus by the Conference of the Parties, and based on such a scale of assessments of the United Nations as may be adopted from time to time by the General Assembly.¹
2. The General Assembly adopted resolution 79/249 containing the scale of assessments for the contributions of Member States to the regular budget of the United Nations for 2025–2027. The indicative scale of contributions from Parties to the Convention for 2024–2025, contained in the annex to decision [19/CP.28](#), and that from Parties to the Kyoto Protocol, contained in the annex to decision [5/CMP.18](#), have been revised to ensure that they are based on the United Nations scale of assessments applicable for that period. The indicative contributions for 2025, based on the revised scales, are reflected in tables 1–2. The Subsidiary Body for Implementation will be invited to consider the revised scales and to recommend draft decisions on the matter for consideration and adoption at the thirtieth session of the Conference of the Parties and the twentieth session of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol.
3. Notifications were dispatched by the secretariat to Parties regarding their contributions for 2025 based on the indicative scales of contributions adopted in the decisions referred to in paragraph 2 above. The secretariat will inform Parties of any changes in the status of contributions resulting from the possible adoption of the revised scales.
