## II. Annotations to the provisional agenda

### 1. Opening of the session

1. SBSTA 64 will be opened by the SBSTA Chair, Adonia Ayebare (Uganda), on 8 June 2026.

### 2. Organizational matters

#### (a) Adoption of the agenda

2. The provisional agenda, prepared by the secretariat in agreement with the SBSTA Chair, will be presented for adoption.

#### (b) Election of officers other than the Chair

3. *Background:* The SBSTA shall elect its Rapporteur for 2026. The current Rapporteur, Rita Mishaan (Guatemala), will remain in office until her successor is elected. Parties are invited to recall decision [3/CP.23](#) and actively consider nominating women.

4. When the SBSTA exercises its functions with regard to matters concerning the Kyoto Protocol, any member of its Bureau representing a State that is a Party to the Convention but at that time not a Party to the Kyoto Protocol shall be replaced by an additional member to be elected by and from among the Parties to the Kyoto Protocol. This applies mutatis mutandis to the SBSTA exercising its functions with regard to matters concerning the Paris Agreement.

5. *Action:* The SBSTA will be invited to elect its Rapporteur for 2026.

(c) Organization of the work of the session

6. SBSTA 64 will be held in parallel with SBI 64. Information on the organization of the work of the session will be made available on the session web page.<sup>3</sup> Delegates are invited to refer to the overview schedule<sup>4</sup> and the in-session Daily Programme<sup>5</sup> and to regularly consult the screens at the venue and the virtual conference platform for up-to-date information on the work of the SBSTA. To maximize negotiation time and ensure timely closure of the sessions, the Chairs of the subsidiary bodies will propose, in consultation with Parties and in a transparent manner, time-saving approaches to the organization and scheduling of meetings during the sessions, taking into account previous relevant SBI conclusions.<sup>6</sup> In this context, the Chairs will propose cut-off times for group work and deadlines for the submission of conclusions so that they can be made available in all six official languages of the United Nations for the closing plenaries.

7. The Chairs of the subsidiary bodies will issue, under their own responsibility, a joint note in advance of SB 64 that will include a proposed approach to the work and guidance on working efficiently, effectively and transparently during the sessions.

(d) Mandated events<sup>7</sup>

8. The following events are mandated to take place in conjunction with SBSTA or SB 64:

- (a) Eighteenth meeting of the research dialogue;
- (b) Annual ocean and climate change dialogue;
- (c) Events relating to the Local Communities and Indigenous Peoples Platform;
- (d) In-session workshop, including plenary presentations and round-table discussions, in conjunction with the 9<sup>th</sup> meeting of the GCNMA;
- (e) Meeting under the Veredas Dialogue on the implementation of Article 2, paragraph 1(c), of the Paris Agreement and its complementarity with Article 9 of the Paris Agreement;
- (f) Dialogue on opportunities, challenges and barriers in relation to enhancing international cooperation related to the role of trade;
- (g) Dialogue on how the outcomes of the global stocktake are informing the preparation of nationally determined contributions;
- (h) United Arab Emirates dialogue on implementing the global stocktake outcomes;
- (i) Dialogue on mountains and climate change;
- (j) Workshop under the Baku Adaptation Road Map;
- (k) Workshop under the Sharm el-Sheikh joint work on implementation of climate action on agriculture and food security;
- (l) Activities under the forum on the impact of the implementation of response measures:
  - (i) 14<sup>th</sup> meeting of the KCI;
  - (ii) Technical session to consider the case studies contained in the KCI annual report for 2025;
  - (iii) Technical session to determine the information to be provided for the technical assessment component of the second global stocktake;

(iv) Technical session to build awareness of and share information related to analysing, assessing and reporting on the impacts of measures taken to combat climate change, including cross-border impacts, recalling Article 3, paragraph 5, of the Convention.

9. Detailed information on these mandated events is available on the UNFCCC website.<sup>8</sup>

### 3. Research and systematic observation

10. *Background:* During the first sessional period of each year, the SBSTA focuses its consideration on scientific advances and research gaps and needs.<sup>9</sup> The eighteenth meeting of the research dialogue will be held in conjunction with SB 64; the discussions at the dialogue may inform the consideration of this matter.

11. *Action:* The SBSTA will be invited to consider this matter with a view to determining further action, as appropriate.

### 4. Matters relating to adaptation

#### (a) Global goal on adaptation\*

12. *Background:* CMA 7 concluded the United Arab Emirates–Belém work programme on indicators for measuring progress achieved towards the targets referred to in paragraphs 9–10 of decision [2/CMA.5](#) and adopted the Belém Adaptation Indicators.<sup>10</sup>

13. CMA 7 decided to establish the Belém–Addis vision on adaptation, which comprises a two-year policy alignment process by Parties, based on the experience referred to in paragraphs 11–12 of decision [12/CMA.7](#) and the technical work referred to in paragraph 14 below, aimed at developing guidance for operationalizing the Belém Adaptation Indicators under the vision, and agreed that work under the vision will be carried out jointly by the subsidiary bodies.<sup>11</sup>

14. CMA 7 requested the subsidiary bodies to undertake technical work on improving metadata and methodologies for the Belém Adaptation Indicators, to be considered at CMA 9, including by establishing a technical task force to contribute to that work.<sup>12</sup>

15. The President of CMA 7 noted that decision [12/CMA.7](#) as adopted allows for further work, and CMA 7 requested SB 64 to conduct such work on the basis of the work undertaken at CMA 7.<sup>13</sup>

16. CMA 7 decided that the first phase of the Baku Adaptation Road Map, covering 2026–2028, shall focus on initial implementation of activities under the Road Map, consisting of the organization of two workshops per year convened by the Chairs of the subsidiary bodies with the support of the secretariat, and the preparation of a technical paper by the secretariat, aimed at enhancing adaptive capacity, strengthening cooperation and facilitating adaptation planning and implementation in line with different national circumstances and in the context of Article 2, paragraph 1(a), of the Paris Agreement.<sup>14</sup>

17. CMA 7 also decided that the subsidiary bodies will develop and agree in 2026–2027 the terms of reference for the review of the United Arab Emirates Framework for Global Climate Resilience, which will include the review of the Belém Adaptation Indicators.<sup>15</sup>

18. *Action:* The SBSTA and the SBI will be invited to continue consideration of this matter.

(b) Review of the progress, effectiveness and performance of the Adaptation Committee\*

19. *Background:* COP 26 invited CMA 4 to participate in the review of the progress, effectiveness and performance of the Adaptation Committee, mandated to take place at COP 27, as it relates to the Paris Agreement.<sup>16</sup>

20. COP 27 and CMA 4 noted that consideration of the review could not be completed at those sessions and would therefore continue at SB 58.<sup>17</sup> SB 58, 59, 60, 61 and 62 continued consideration of the review.<sup>18</sup> SB 63 agreed to defer consideration of this matter to SB 64.<sup>19</sup>

21. *Action:* The SBSTA and the SBI will be invited to continue consideration of this matter with a view to recommending draft decisions thereon for consideration and adoption at COP 31 and CMA 8.

(c) Nairobi work programme on impacts, vulnerability and adaptation to climate change

22. *Background:* The NWP functions as the UNFCCC knowledge-to-action hub for adaptation and resilience by delivering knowledge and know-how for scaling up adaptation action and strengthening resilience to current and future climate change impacts across systems and communities. It drives community-, country- and region-specific collaboration through its network of close to 500 partner organizations, engaging diverse knowledge holders in the co-creation, curation and delivery of trusted, timely, understandable and actionable knowledge and practical know-how tailored to the specific and evolving needs of countries, in particular developing countries, and communities.

23. SBSTA 48 concluded that the SBSTA would consider matters related to the NWP at its first regular session of each year and requested the secretariat to prepare a concise annual progress report with an executive summary on progress in implementing activities under the NWP for consideration by the SBSTA at those sessions.<sup>20</sup>

24. SBSTA 62 welcomed the progress between May 2024 and March 2025 and took note of the efforts in implementing activities under the NWP.<sup>21</sup>

25. SBSTA 62 requested the secretariat to implement the activities under the NWP in a regionally balanced manner, and to consider including therein priority thematic areas as mandated<sup>22</sup> and to consider early warning systems, as appropriate, and invited Parties, NWP partner organizations and other relevant organizations to provide financial and in-kind support, as appropriate, for the implementation of activities under the NWP.<sup>23</sup>

26. *Action:* The SBSTA will be invited to consider progress in implementing activities under the NWP, drawing on the annual progress report for 2026 prepared for this session, and to provide further guidance, as appropriate.

## 5. Sharm el-Sheikh mitigation ambition and implementation work programme\*

27. *Background:* CMA 3 established a work programme for urgently scaling up mitigation ambition and implementation in this critical decade.<sup>24</sup>

28. CMA 5 requested the subsidiary bodies to consider progress in implementing the Sharm el-Sheikh mitigation ambition and implementation work programme at each of their sessions from SB 60 to 65.<sup>25</sup>

29. CMA 7 recalled paragraph 5 of decision [4/CMA.4](#), in which it was decided that implementation of the work programme will continue until CMA 8 with a view to a decision on the continuation of the work programme being adopted at that session, and invited Parties, observers and other stakeholders to submit views by 15 April 2026 on opportunities, best practices, actionable solutions, challenges and barriers relevant to the continuation, functioning and effectiveness of the work programme with a view to an exchange of views taking place at SB 64.<sup>26</sup>

30. The President of CMA 7 noted that decision [13/CMA.7](#) as adopted allows for further work, and CMA 7 requested SB 64 to conduct such work on the basis of the work undertaken at CMA 7.<sup>27</sup>

31. *Action:* The SBSTA and the SBI will be invited to consider progress in implementing the work programme and the continuation thereof.

## 6. United Arab Emirates just transition work programme\*

32. *Background:* CMA 4 established a work programme on just transition for discussion of pathways to achieving the goals of the Paris Agreement outlined in Article 2, paragraph 1, in the context of Article 2, paragraph 2.<sup>28</sup>

33. CMA 5 decided that the subsidiary bodies shall guide the implementation of the United Arab Emirates just transition work programme through a joint contact group to be convened at each of their sessions with a view to them recommending a draft decision on this matter for consideration and adoption by the CMA at each of its sessions.<sup>29</sup>

34. CMA 7 decided to develop a just transition mechanism and requested SB 64 to recommend a draft decision on the process for its operationalization for consideration at CMA 8. CMA 7 invited Parties and non-Party stakeholders to submit views on this process.<sup>30</sup>

35. CMA 7 recalled paragraph 3 of decision [3/CMA.5](#), in which it was agreed to review the effectiveness and efficiency of the work programme and consider its continuation at CMA

8, and requested SB 64 to develop terms of reference for the review, and to consider, inter alia, ways to improve existing modalities in developing the terms of reference, without prejudice to the outcome of the consideration of the continuation of the work programme.<sup>31</sup>

36. *Action:* The SBSTA and the SBI will be invited to continue consideration of the matters referred to in paragraphs 33–35 above with a view to recommending draft decisions thereon for consideration and adoption at CMA 8.

## 7. Matters relating to the forum on the impact of the implementation of response measures serving the Convention, the Kyoto Protocol and the Paris Agreement\*

37. *Background:* COP 29, CMP 19 and CMA 6 adopted the workplan for 2026–2030.<sup>32</sup>

38. COP 30, CMP 20 and CMA 7 requested the forum and its KCI to implement the workplan for 2026–2030 and make recommendations to the governing bodies consistent with the functions of the forum and its KCI.<sup>33</sup>

39. COP 30, CMP 20 and CMA 7 decided that forum will conduct the activities referred to in paragraph 10 of decisions [6/CP.30](#), [2/CMP.20](#) and [14/CMA.7](#) at SB 64.<sup>34</sup>

40. *Action:* The SBSTA and the SBI will be invited to convene the forum with a view to recommending a draft decision on matters relating to the forum for consideration and adoption at COP 31, CMP 21 and CMA 8.

## 8. Sharm el-Sheikh joint work on implementation of climate action on agriculture and food security\*

41. *Background:* COP 27 decided to establish the Sharm el-Sheikh joint work.<sup>35</sup>

42. SB 60 requested the secretariat to prepare the annual synthesis report referred to in paragraph 15(a) of decision [3/CP.27](#) and make it available for consideration at the first regular sessions of the subsidiary bodies each year.<sup>36</sup>

43. SB 62 requested the secretariat to provide an update at SB 64 on the usage of and traffic to the Sharm el-Sheikh online portal developed by the secretariat.<sup>37</sup>

44. SB 63 agreed that consideration of this matter will continue at SB 64 taking into account the draft text<sup>38</sup> prepared for these agenda items at SB 63.<sup>39</sup>

45. *Action:* The SBSTA and the SBI will be invited to continue consideration of this matter with a view to determining next steps.

## 9. Matters relating to technology development and transfer: joint annual report of the Technology Executive Committee and the Climate Technology Centre and Network\*

46. *Background:* The Technology Executive Committee and the Climate Technology Centre and Network prepare and submit a joint annual report to the COP<sup>40</sup> and the CMA<sup>41</sup> on their respective activities and the performance of their respective functions. SB 63 could not conclude consideration of this matter.<sup>42</sup>

47. COP 30 and CMA 7 requested SB 64 to continue consideration of this matter on the basis of the latest draft text<sup>43</sup> prepared at SB 63.<sup>44</sup>

48. *Action:* The SBSTA and the SBI will be invited to continue consideration of the joint annual report of the Technology Executive Committee and the Climate Technology Centre and Network for 2025 and recommend draft decisions thereon for consideration and adoption at COP 31 and CMA 8.

## 10. Matters relating to Article 6, paragraph 8, of the Paris Agreement

### (a) Meeting of the Glasgow Committee on Non-market Approaches

49. *Background:* The GCNMA is convened by the SBSTA Chair and meets in conjunction with the first and second regular sessions of the SBSTA each year.<sup>45</sup> GCNMA 9 will take place in conjunction with this session.

50. SBSTA 63 convened GCNMA 8 and welcomed the progress of implementation and outcomes of the work programme under the framework for non-market approaches referred to in Article 6, paragraph 8, of the Paris Agreement and in decision [4/CMA.3](#), the broad participation of Parties, relevant bodies, representatives of institutional arrangements and processes under the Convention and the Paris Agreement, and observers, including through the delivery of presentations, world cafés and round-table discussions, in the in-session workshops held in conjunction with GCNMA 7 and 8,<sup>46</sup> and the constructive use of spin-off groups at GCNMA 7 and 8.<sup>47</sup>

51. CMA 7 invited Parties to consider national processes for identifying and selecting NMAs under the identified focus areas of the work programme activities,<sup>48</sup> as appropriate,

and invited Parties and their national focal points for Article 6, paragraph 8, of the Paris Agreement, as appropriate, to share their experience, best practices, lessons learned and case studies pertaining to NMAs with a view to improving implementation thereof, including by making use of the NMA Platform's online discussion forum and the in-session workshops and spin-off groups at meetings of the GCNMA. CMA 7 also invited Parties to record their NMAs on the NMA Platform to facilitate information exchange and stakeholder engagement and to make use of the discussion forum for collaborating on potential NMAs.<sup>49</sup>

52. *Action:* The SBSTA will be invited to convene GCNMA 9 with a view to continuing to implement the activities of the work programme, and to determine further action, as appropriate.

(b) Review of the work programme under the framework for non-market approaches referred to in Article 6, paragraph 8, of the Paris Agreement and in decision 4/CMA.3

53. CMA 3 requested SBSTA 64 and 65 to review the work programme under the framework for non-market approaches, including its activities, with a view to enhancing the effectiveness of the work programme, taking into account relevant inputs, including the outcomes of the global stocktake, and to make recommendations thereon for consideration and adoption at CMA 8.<sup>50</sup>

54. CMA 7 emphasized that the review of the work programme, including its activities, should provide clear added value by focusing on improving the effectiveness of the work programme, including by increasing use of the NMA Platform as a hub for recording, exchanging and identifying information on NMAs.<sup>51</sup>

55. CMA 7 requested the secretariat to produce a synthesis report on the key takeaways from the annual progress reports of the GCNMA, focusing on the elements outlined in paragraph 9 of the annex to decision [4/CMA.3](#); gather experience of national focal points for Article 6, paragraph 8, of the Paris Agreement, and the views of stakeholders on their experience with NMAs and the NMA Platform, as well as on the identification of support provided and needed for implementing NMAs; and develop a mapping against other relevant bodies and institutional arrangements and processes under the Convention and the Paris Agreement to provide information on synergies and help to avoid duplication of efforts.<sup>52</sup>

56. CMA 7 also requested the SBSTA to conduct its review of the work programme taking into account the annual progress reports of the GCNMA; statistics on the use of the NMA Platform, including in relation to unique visitors and user activity on the online discussion forum; the experience of national focal points for Article 6, paragraph 8, with the NMA Platform and their relevant views; and the views of stakeholders on how to increase the effectiveness of the work programme activities.<sup>53</sup>

57. CMA 7 further requested the secretariat to deliver a presentation providing an overview of the outcomes of its actions in response to paragraph 55 above at SBSTA 64.<sup>54</sup>

58. CMA 7 requested SBSTA 64, in the context of the work programme under the framework for non-market approaches, to consider ways to implement additional functionalities on the NMA Platform that would enable Parties to record the projects that they identify under the Sharm el-Sheikh mitigation ambition and implementation work

programme through their national focal points for Article 6, paragraph 8, of the Paris Agreement, and enable interconnection between the NMA Platform and other platforms, including national platforms for Parties that request it, with a view to SBSTA 64 recommending a draft decision on this matter for consideration and adoption at CMA 8.<sup>55</sup>

59. CMA 7 also requested the secretariat to prepare a technical paper exploring options for the operationalization of the additional feature and functionality of the NMA Platform for consideration at SBSTA 64 in the context of the work programme under the framework for non-market approaches.<sup>56</sup>

60. *Action:* The SBSTA will be invited to initiate the review of the work programme under the framework for non-market approaches with a view to recommending a draft decision for consideration and adoption at CMA 8.

## 11. Methodological issues

### (a) Greenhouse gas data interface

61. *Background:* SBSTA 62 requested the secretariat to further develop the greenhouse gas data interface using the infrastructure of the climate data hub, incorporating data and information reported by Parties under the Convention, the Kyoto Protocol and the Paris Agreement, with separate data entry labels on the interface; and to develop and publish the modules outlined in the presentation made at SBSTA 62. The SBSTA decided to consider additional modules at SBSTA 64.<sup>57</sup>

62. *Action:* The SBSTA will be invited to continue consideration of this matter with a view to determining next steps, as appropriate.

## 12. Cooperation with other international organizations

65. *Background:* SBSTA 30 requested the secretariat to prepare, before sessions at which this agenda item is to be taken up, an information paper summarizing relevant cooperative activities so as to enable Parties to comment on the information, as appropriate.<sup>59</sup>

66. SBSTA 63 continued consideration of this matter and forwarded the matter to COP 30 for further consideration.<sup>60</sup> COP 30 invited Parties and observers to submit views on enhancing the inclusiveness of cooperation with other international organizations as well as on the cooperation with the other Rio Convention secretariats and agreed that SBSTA 64 will consider the matter further taking into consideration those submissions.<sup>61</sup>

67. *Action:* The SBSTA will be invited to consider the summary report prepared for this session and further consider this matter taking into account the submissions referred to in paragraph 66 above.
