## Twenty-sixth meeting of the Standing Committee on Finance 12–14 October 2021

Pursuant to decision 2/CP.17, section IV, I am pleased to notify admitted non-governmental organizations (NGOs) that the twenty-sixth meeting of the Standing Committee on Finance will take place from 12 to 14 October 2021 in Bonn, Germany from **9 a.m.** to **5 p.m.** Central European Summer Time<sup>1</sup> each day.

Owing to travel restrictions resulting from the COVID-19 pandemic, observers will only be able to participate virtually in the meeting. Representatives of admitted NGOs nominated by constituency focal points must register for the meeting using the observer registration form for NGOs, which has been sent to constituency focal points. Kindly note that only **two representatives per constituency** will be permitted to participate in the official meeting; all other interested observers may follow the proceedings via live broadcast. The broadcast link and meeting documents will be shared prior to the meeting at <a href="https://unfccc.int/scf/scf-meetings-and-documents#eq-1">https://unfccc.int/scf/scf-meetings-and-documents#eq-1</a>.

Once the constituency focal points have confirmed their nominations, the registration forms should be forwarded to <a href="mailto:cool@unfccc.int">cool@unfccc.int</a>.

The deadline for registration as an observer for the meeting is Friday, 1 October 2021. In view of the need to confirm the arrangements for the virtual meeting as early as possible, registrations received after this deadline will not be processed.
