- Question 4 (Linkages): For each of the linkages previously identified, what are the possible outcomes and how do these affect the guidance? For each such linkage, identify which one(s) affect other aspects of the guidance and the priority with which each one should be resolved.
- Question 5 (flexibility/optionality/choice/discretion): Which provisions should be contained in the guidance to ensure the flexibility/optionality/choice/discretion highlighted by Parties?
