Why new workplan?

- As per the rules of procedures, the TEC develops and agrees on workplans to organise its work and activities to implement its functions/mandates
- Workplan is usually updated to reflect new tasks arising from most recent COP decisions/SBs conclusions (=> "rolling" workplan)
- Since its inception, the TEC has implemented three rolling workplans: 2012–2013, 2014–2015, and 2016–2018
- This year, a new rolling workplan is very timely given major outcomes from Katowice that impact the work of the TEC in the coming years
- TEC 17 (Sept 2018) requested TEC Chair & Vice Chair for 2018 to prepare, with the support from secretariat, a draft rolling workplan for consideration at TEC18




What has been done inter-sessionally?

- Looked at various new mandates/tasks from Katowice, in particular Technology framework and Periodic assessment of the Technology Mechanism
- Discussed different approaches to structure the work of the TEC and came to conclusion that developing the detail content of the new workplan would benefit from full deliberation by all TEC members
- Hence, TEC Chair & Vice Chair for 2018 proposed:
 - a) A step-by-step approach to guide the **process** for developing the new workplan
 - b) A high-level structure with strategic objectives and strategic outcomes
- In relation to joint activities with the CTCN, discussed with Chair & Vice Chair of CTCN-AB and proposed potential areas for collaboration (see doc TEC/2019/18/7)




What lessons have been learned from the previous workplan?

- The approach and structure has allowed the TEC to organize its activities to respond to mandates of the Convention as well as of the Paris Agreement in a coherent and effective manner, avoiding duplication or unnecessary delineation of mandates
- Yet there are still challenges in implementing TEC workplan and activities (highlighted in TEC annual reports to the COP in 2017 & 2018), e.g.:
 - Availability of financial resources to implement workplan → TEC will continue to implement its workplan as efficiently as possible, recognizing the need to address its mandates subject to resource availability
 - To effectively monitor and evaluate impacts of its activities, appropriate methodologies and indicators, and sufficient data and information are needed
